### HOW TO GET RECORD TITLES APPROVED?

**Click on Title Check tile on homepage.**

On Title Check Page, fill the Title Check application form where user himself has to describe the record facts with Title and Description along with Title option (New/Existing) so that team should be able to understand the fact and shall grant the permission.

**Choose Title and Service Option**

**Title Option:** Existing Title Check                      New Title Check

**Service Option if Title Option is for: Existing Title Check**

- Slow Check Fee: Free: - Get title approval or rejection within 4 weeks.
- Rapid Check Fee: INR 200/- Get title approval or rejection within 24 hours.

**Service Option if Title Option is for: New Title Check**

- Slow Check Fee: 200/- Get title approval or rejection within 4 weeks.
- Rapid Check Fee: INR 500/- get title approval or rejection within 24 hours.

Once you have submitted the required information for the title approval, you will get title approval or rejection within 24 hours or 4 weeks as per the service option selected.

Once Title is accepted, proceed to STEP 2, apply for the Guidelines to attempt the Record and/or invite a Judge for on the site Certification.

Here first you need to choose the service option (1.) Free Evidence Review, (2.) Standard Evidence Review, (3.) Express Evidence Review and Fill the complete details in all required columns, attach all the required documents as per the record specific guidelines provided and submit evidence for review.

Once application is submitted you will get confirmation email to acknowledge receipt of this and your application will be activated on our system. If your record verification got successful after verifying all the documents about the records, our Record Management Team will send the Record Approval e-mail with subject "Official Unique World Records – Record". Once Record status is granted to applicant, applicant will receive email with the link to order Free Certificate and other paid accessories.

If, however, your verification got unsuccessful, we'll get back to you with an explanation of why it was not approved. A grace period of 15 days to resubmit the default documents will be given. It is not a guarantee that your application will be approved by us as a potential record category as the decision is based on your supporting evidence and /or relevance of your claim. If your record verification got un-successful after verifying all the documents about the records, we will share the valid reason of record rejection.

### WHAT ARE THE COMMON GUIDELINES FOR EVIDENCE?

Collecting and submitting proper evidence is your obligation. You are advised to carefully read and understand the particular evidence requirements. Along with Record specific guidelines you get all forms in prescribed formats which you need to download and duly fill them as instructed. Wisely and logically consider the type of materials you intend to submit. Instantaneous collecting of evidence is very important as negligence may result into disqualification.

### WHAT TYPES OF RECORDS CAN BE ATTEMPTED?

Usually we get applications for records which are of the following nature such as Measurable (biggest / fastest / most / extraordinary etc.), Verifiable, one Variable, Universal, Best in the World, reproducible, breakable and based on skill. Freak, strange and unusual anomalies are not world records. Stunts involving luck or uncontrolled danger should not be submitted. Minor applicants are not supposed to attempt or undertake records which are considered to be unsuitable and unsafe, all applicants are informed to avoid any illegal activity for breaking or setting a record. No animals should be harmed in the pursuit of record attempt. If your proposed record title is similar to the one we already have in UWR database, we encourage you to break the existing record instead of approving a similar title. Unique World Records only recognises WORLD records. UWR do not verify national / country specific records.

### HOW DO I KNOW ABOUT THE EXISTING RECORD I WANT TO BREAK?

Current world records are enlisted with details on our website, [www.uniqueworldrecords.com](http://www.uniqueworldrecords.com), where you can search your desired keywords, describing the title, you will find the existing record details.

### IF I'M NOT SUCCESSFUL THIS TIME, CAN I RE-ATTEMPT THE RECORD?

Yes of course, you must APPLY through a fresh application for your reattempt, as your previous application was rejected for being unsuccessful. UWR welcome and encourage you to reattempt the record. Many applications regularly challenging the records are received by us.

### DO THE RECORD TITLES HAVE ANY RULES & GUIDELINES?

Yes of course, set of rules and guidelines plays a vital role in the process of achieving a world record. There are two types of guidelines viz. General Guidelines and Record Specific Guidelines. A complete list of rules is also sent to every applicant, but the rules and guidelines are non-exhaustive and UWR do not offer any guarantee or warranty of making your attempt risk free. UWR advise you to get expert help and proper safety equipment before attempting a record involving risk for you or anyone else. Rules and Guidelines are sent to every applicant at an appropriate time.

### WHAT IS EXISTING / NEW TITLE CHECK OPTION ON THE TITLE CHECK APPLICATION?

To Set/Break or Submit a record, first applicants need to get their Record Title approved. At the time of application, applicants need to choose the title option for processing title check application which is of two types namely Existing Title Check and New Title Check Option. If you are applying for a title approval that is already available on our database it will be considered as Existing title and if title is not available on our website it will be considered as New Title Check.

Once you have submitted the required information for the title approval, you will get title approval or rejection within 24 hours / 4 Weeks as per the service option selected.

Once you have submitted the required information for the title approval, you will get confirmation email that your request has been received and you will get response within 2 working days / 4 weeks as per the service mode selected.

### WHAT ELSE DO I NEED TO SEND?

The record details will be freely given to interested third parties, without prejudice, such as the press, media and general public.

### WHAT IS THE COST TO SET A UNIQUE WORLD RECORD?

We hardly charge anything. The only time Unique World Records might expect payment is if you need to use our premium service options – and if members of our staff have, by arrangement, attended your event on invitation.
